

Over the past year we had a record 1,620 donors contribute \$771,224 in support of a number of organizations and causes throughout Houghton and Keweenaw county. One of the most trying moments was the Father's Day floods, which tested the resiliency of our community. You all responded in a huge way, helping your neighbors get back on their feet and back into their homes through an unprecedented donation of funds and volunteer hours.

The number of KCF funds grew to 114, encompassing a variety of organizations and initiatives. \$212,584 was granted to 42 organizations, 6 scholarships, and 9 Youth Advisory Council grants. It was an incredible year of giving back to the community. On this 25th Anniversary milestone we recognize the roll our donors have had in strengthening all aspects of the Keweenaw and we look forward to your support over the next 25 years and beyond. STUDENT LEADERSHIP ADVISORY COUNCIL OF THE KEWEENAW

Student Leadership Advisory Council of the Keweenaw (SLACK) is part of the Keweenaw Community Foundation. Their purpose is to address youth needs in Houghton and Keweenaw counties.

MISSION STATEMENT

Bridging gaps between Keweenaw communities by engaging in youth philanthropy and developing student leadership.

GOALS

- Engage youth in philanthropy
- Engage youth in addressing the needs of local youth
- Engage youth in community service
- Engage youth in promoting leadership

HISTORY

In 1992, the trustees of the Community Foundation for Keweenaw and Houghton Counties created the Youth Advisory Committee in response to a challenge issued by the W.K. Kellogg Foundation. The Kellogg Foundation contributed \$500,000 to the Keweenaw Community Foundation to create an endowment to be managed for and by youth in Houghton and Keweenaw Counties.

Today, there are over 1,500 young people serving on 86 youth grantmaking committees statewide. Endowment fund assets exceed \$62 million and collectively give \$1.5 million in grants per year. Our youth council alone has granted nearly \$150,000 in funds since its inception.

In 2019 the YAC program improved its student and community outreach by working with the Copper Country ISD Student Leadership Council (SLC). Together the students decided rename the joint council SLACK (Student Leadership Advisory Council of the Keweenaw) in September of 2019.

DISASTER RELIEF AFTER THE FLOODS

A community coming together, showing its resiliency

The Keweenaw Community Foundation and a number of partnering organizations worked with our community to recover from the Father's Day Floods of 2018. The donations that were entrusted to the KCF were utilized to support the flood relief efforts and victims. Over \$350,000 was utilized for assisting those affected by the floods by helping them getting back in their homes; temporary housing; transportation; mold abatement; and more. 109 families applied for and received help in the first two phases of the recovery process, receiving assistance immediately after the floods. The KCF wishes to acknowledge the people and businesses within our community and further afield who contributed to relief efforts through individual fundraising initiatives and contributions to the Disaster Relief fund.

Over the course of the recovery and relief process, we worked with community agencies and United Methodist Committee on Relief (UMCOR) in assisting those affected through the disaster case managers funded by UMCOR.

Moving forward into the future, the Keweenaw Community Foundation is working with other organizations and granting agencies to further efforts in making sure our infrastructure, environment, and recovery processes are more resilient.

A WEALTH OF ENERGY

We partnered with New Power Tours Inc. on a Clean Energy Initiative grant received from the Charles Stewart Mott Foundation. Through this initiative, the project enabled seven local 501(c)3 organizations to replace their incandescent lighting with LEDs; replace 7 pumps in heating systems with electronically commutated motor units (ECM's); and replaced the local thrift store's washer and dryer with energyefficient commercial models. In addition to the energy efficiency support, the project hosted an Energy Summit and worked throughout the year winterizing the homes of Copper Country low-income, ALICE, and elderly residents. 25 YEAR CELEBRATION

This year's annual "Keweenaw Gold" event highlighted our 25th Anniversary. Over 80 attendees came out to the Miscowaubik Club in Calumet to celebrate and support the foundation's past, present, and future. It was a special evening with many community members from across the Keweenaw coming together to enjoy good food and company, and to help raise funds for our community foundation.

Multiple awards were presented at the event. Robert Maatta received the Herman "Winks" Gundlach Award for the greatest contribution to a KCF fund over the past financial year. The Volunteer of the Year Award—normally presented to an individual who has made numerous volunteer efforts to make our community a better place—was presented to all the Father's Day Flood volunteers. The Community Impact Award went to the Portage Health Foundation who also greatly helped the community in the immediate aftermath of the Father's Day Floods. The Martha and Floyd Heart & Hands Society was awarded to Carol Ekstrom, a passionate and active environmentalist and organizer.
